



**END USER LICENSE AGREEMENT**  
**Non-exclusive License to use the Product**  
**Basic user License**

THIS END USER LICENSE AGREEMENT (“**LICENSE**”) IS A LEGAL AGREEMENT BETWEEN THE **LICENSEE** (AS DEFINED BELOW) AND GEO SAT LDA (“**LICENSOR**”) AND REGULATES THE USE OF ANY AND ALL LICENSOR’S INTELLECTUAL PROPERTY RIGHTS, IN PARTICULAR LICENSOR’S DATA OR SOFTWARE (THE “**PRODUCT**”) BY YOU, THE **END USER** (AS DEFINED BELOW), THAT IS NOT OTHERWISE SUBJECT TO AN INDEPENDENT LICENSE AGREEMENT. PLEASE READ CAREFULLY THE FOLLOWING INFORMATION. YOU AND LICENSEE WILL BE DEEMED TO HAVE ACCEPTED AND AGREED TO THE TERMS AND CONDITIONS OF THIS LICENSE IF YOU (A) INSTALL AND/OR USE AND/OR MANIPULATE THE PRODUCT; OR/AND (B) BREAK THE SEAL OF ANY PACKAGE CONTAINING THE PRODUCT; OR/AND (C) RETAIN THE PRODUCT FOR MORE THAN FOURTEEN (14) CALENDAR DAYS. IF YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS OF THIS LICENSE, YOU MUST REFRAIN FROM (A) BREAKING THE SEAL OF THE PRODUCT OR/AND (B) INSTALLING AND/OR USING THE PRODUCT, AND MUST RETURN THE PRODUCT TO LICENSOR WITHIN FOURTEEN (14) CALENDAR DAYS OF LICENSEE’S RECEIPT OF THE PRODUCT.

**1. Definitions:**

- 1.1. “**Licensee**” means the natural person or legal entity or non-governmental organization or non-profit organization or university or local, regional, state or federal administrative entity, or agency, who has acquired the Product and to who the Licensor grants this License. For greater certainty, Licensee may not distribute, transfer or otherwise make available the Product to any subsidiary or affiliate of Licensee, or any other users, without the prior written consent of Licensor, except as expressly provided in this License.
- 1.2. “**End User**” means the natural person belonging to or working for or contracted by the Licensee who will use in practice the Product and who will be committed to the Licensor by the terms and conditions of this License.
- 1.3. “**Value Added Product**” means unique products developed and produced by the Licensee that contain imagery data from the Product, as long as it purports a significant modification of the original Product, through manipulation techniques and/or addition of other data.
- 1.4. “**Derivative Works**” means any derivative product or information developed by the Licensee from the Product which does not contain any imagery data from the Product and is irreversible and uncoupled from the source imagery data of the Product.
- 1.5. “**Particular Conditions**” means any particular provisions applicable to the Product that, in such case, are defined in the agreement by means of which the Product is acquired by the Licensee.

**2. Ownership of intellectual property:**

- 2.1. The Product is licensed, not sold, there is no ownership transfer. All ownership, rights and title in and to all intellectual property in or related to the Product is and will remain the exclusive property of Licensor. Licensor owns and will continue to own all title in any copy, translation, modification, adaptation or derivation of the Product, including any kind of output that contains



the pixel structure and information of the original imagery data from the delivered Product, except as expressly provided in this License or in the Particular Conditions.

2.2. All ownership, rights and title in and to all intellectual property in or related to the Value Added Product and to Derivative Works will be and remain the exclusive property of Licensee.

**3. Grant of License:** Licensor grants to Licensee a limited, non-transferable, non-exclusive, revocable (in accordance with the terms hereof) License to use the Product and any accompanying written materials, and anything derived therefrom, solely as set forth in this License.

**4. Permitted Uses:** Pursuant to this License, Licensee and End User may:

4.1 use the product for their own internal needs;

4.2 make one copy of the Product for internal backup purposes only;

4.3 alter or modify the Product to produce Value Added Products and/or Derivative Works (each as defined herein);

4.4 provide the Product and Value-Added Products to End Users for Licensee's internal use of the Product and Value-Added Products; provided such End Users are under a duty of confidentiality no less restrictive than Licensee's duty hereunder. The external End Users authorised to use the Product according to the provisions defined hereby must not retain the Product or Value Added Products or copies thereof after completion of Licensee's internal project;

4.5 use any Value-Added Product for its own internal purposes; and

4.6 freely use and distribute Derivative Works.

**5. Prohibited Uses:** Pursuant to this License, Licensee and End User shall not do anything other than those things permitted in Section 4 including, without limitation, and shall not:

5.1 sell, lease, rent, sub-license, or transfer the Product or Value-Added Products, in any manner whatsoever;

5.2 reverse engineer, disassemble, or decompile the Product;

5.3 alter or remove any copyright notice or proprietary legend contained in or on the Product; or

5.4 on its own, or permit any third party to, release or publicly post, publish or broadcast the Product or Value-Added Products, including posting to any Internet web sites, for any purpose.

**6. Copyright:** The following copyright notice, or such other copyright notice as Licensor may advise Licensee, must be conspicuously displayed alongside the Product, or any portion thereof: "Copyright © GEOSAT" must appear as a credit.

**7. Warranty:** Licensor warrants that the media upon which the Product is delivered will, for ninety days from the date of delivery, be free from defects and substantially conform to Licensor's specifications when used on appropriate computer hardware. In case of breach of warranty or other duty related to the quality of the Products reported by the Licensee to Licensor during the applicable warranty period, Licensor shall correct or replace the defective Product or, if Licensor determines such remedies are not practicable, terminate this License with respect to the affected Product, accept the return or deletion of the deficient Product, and refund to the Licensee the amount fully paid to Licensor for such Product.



**8. Exclusions:** Licensee accepts sole responsibility to have determined the Product is suitable for its purposes and use. Licensee acknowledges and agrees that the use of the Product is at its sole risk. Except expressly as stated herein, the Product is licensed “as is,” and Licensor disclaims any and all other warranties, whether express or implied, including, without limitation, any implied warranties and conditions of merchantability or fitness for purpose, or with respect to the character, function, or capabilities of the Product or its appropriateness for Licensee’s purposes. Licensor specifically makes no warranty that the data contained in the Product will allow uninterrupted use or is error free or that defect in the Product can or will be corrected. Licensor further makes no warranty regarding the use of, or results of the use of, the Product in terms of its correctness, accuracy, reliability or otherwise. Licensor specifically makes no warranty, and accepts no liability, for the spread of computer viruses via the Product or the media on which it is delivered.

**9. Limitation of Liability:** regardless of whether any remedy set forth herein fails to achieve its essential purpose, in no event will the liability, if any, of Licensor for damages relating to the Product or otherwise arising out of, related to, or in any way connected with this License exceed the actual amount Licensee paid for the specific Product that directly gave rise to the damages claimed, regardless of the form of action, whether based on contract, negligence, products liability, trade practices, or otherwise. In no event will Licensor be liable for any consequential, indirect, special, punitive, or incidental damages or lost profits, whether foreseeable or unforeseeable, of any kind. The limitations contained in this Section are not made where prohibited by law.

**10. Compliance with laws:** Licensee and End User will comply with all applicable licensing and import and export laws, restrictions and regulations of all applicable jurisdictions that may be in effect during the term of this License.

**11. Compensation for damages:** Licensee and End User acknowledge that any actual or threatened breach of this License would likely cause Licensor irreparable harm that could not be fully remedied by monetary damages. Licensee shall indemnify and hold harmless the Licensor for and against any damage, loss, liability, expense, or other claims, including costs and fees for defending such claims, that Licensor may incur as a result of, related to or in connection with Licensee’s or End User’s failure to comply with any applicable law, regulation or order. In addition, Licensor will have the right to seek injunctive or other equitable relief from a court of competent jurisdiction, without proof of actual damage, as may be necessary to prevent such breach.

**12. Termination:** Licensor may terminate this License, effective immediately, upon notice to Licensee, if Licensee or End User breach any provision of this License. Upon termination of this License, all rights granted to Licensee and to End User hereunder will immediately cease, without any liability of Licensor.

**13. Governing law and Jurisdiction:** 1. This License will be governed by and construed in accordance with the laws of Portugal. 2. The parties irrevocably and unconditionally agree that all dispute, controversy or claim arising out of or relating to this License, or the breach, termination



or invalidity thereof, shall be exclusively settled by the competent courts of the city of Lisbon (Portugal), and expressly renounce to any other jurisdiction that may be applicable.

**14. Miscellaneous:**

14.1. Sole agreement. This License is the sole and entire agreement, together with the Particular Conditions, if any, between Licensor and Licensee with regard to the Product and which regulates the use of such Product by the End User.

14.2. Amendments. This License cannot be modified or rescinded, nor may any of its terms be cancelled or waived, unless approved in writing by Licensor. This License applies to any upgrades or supplements to the original Product provided by Licensor, unless Licensor provides other terms together with the upgrades or supplements to the original Product. In case of conflict between these terms, the second shall prevail.

14.3. No waiver. The failure of Licensor to insist upon strict performance of any of the terms and conditions of this License will not be deemed a waiver of any rights or remedies that Licensor may have and will not be deemed a waiver of any subsequent default of the terms and conditions of this License.

14.4. Prohibition to assign or to transfer. Neither this License nor any of the rights or obligations hereunder may be assigned or transferred by Licensee or End User without the prior written consent of Licensor. This restriction on assignment or transfer will apply to assignments or transfers by operation of law, as well as by contract, merger or consolidation.

14.5. Severability. In the event that any provision of this License is declared invalid or unenforceable, the remaining provisions of this License will continue in full force and effect.

14.6. Audits. Upon notice, Licensor or its representatives may inspect Licensee's and/or End/Users' records, accounts and books relating to the use of the Product to ensure that the Product is being used in accordance with this License.

14.7. Language. This License may be provided in different languages. In the event of any discrepancies, omissions, or errors between the languages, the English language version shall take precedence.
